Business:

**1. Consideration and possible action: Adoption of an Order Canvassing the Returns and Declaring the Results of a General City Officers' Election**

City Manager Joe Dickson read the vote totals for the General City Officers' Election. There were 1,111 qualified votes cast and the candidates received the following votes:

**COUNCIL, PLACE 1**

Shana Hansen	92 early votes	150 total votes
Pam Schwertner	215 early votes	376 total votes
Joe Carothers	320 early votes	510 total votes

**COUNCIL, PLACE 4**

Scot Rice	235 early votes	403 total votes
Ronald "Bubba Jannett"	364 early votes	584 total votes

**COUNCIL, PLACE 5**

Pat McCrary	438 early votes	690 total votes
Bob Braeking	170 early votes	312 total votes

Motion by Councilmember McCrary, seconded by Councilmember Jannett to adopt the Order Canvassing the Returns and Declaring the Results of a General City Officers' Election. The motion passed the roll call vote unanimously.

**2. Consideration and possible action: Adoption of an Order Canvassing the Returns and Declaring the Results of a Special Bond Election**

City Manager Joe Dickson read the vote totals for the Special Bond Election. There were 1,111 qualified votes cast and Proposition 1 received the following votes:

FOR	414 early votes	662 total votes
AGAINST	255 early votes	446 total votes

Motion by Councilmember Carothers, seconded by Councilmember McCrary to adopt the Order Canvassing the Returns and Declaring the Results of a Special Bond Election. The motion passed the roll call vote unanimously.

**3. Consideration and possible action: Adoption of a resolution issuing an order for the general city officers' runoff election to be held June 22, 2013, and establishing procedures for the election**

City Manager Joe Dickson said a runoff election between the two candidates receiving the highest number of votes cast for Council, Place 1, since no candidate received a majority of the votes cast for that position. Motion by Councilmember Jannett, seconded by Councilmember McCrary to adopt the resolution issuing an order for the general city officers' runoff election to be held June 22, 2013, and establishing procedures for the election. The motion passed the roll call vote unanimously.

Motion by Councilmember Jannett, seconded by Councilmember McCrary to adjourn. The motion passed and the meeting adjourned at 6:05 p.m.
